Prior Learning Assessment and Recognition for Mature Students – Revised Mandatory Requirements

Mature students typically complete their secondary education with specific goals and timelines in order to support their future career and education endeavors. It is important that mature students are supported to expeditiously achieve their Ontario Secondary School Diploma (OSSD) and efficiently move to sustainable employment, postsecondary education and/or apprenticeship.

Prior Learning Assessment and Recognition (PLAR) for Mature Students provides a process by which the prior experiences of adult learners, both formal and informal, can be recognized for secondary credit, minimizing duplication of learning, saving the learner time and opportunity costs, and providing them with an enhanced pathway to high school graduation.
